<p>This course helps students to understand the mechanisms of the legal system covering modern environmental problems by examining important environmental precedents in the U.S.A. as well as the process of formulating and implementing laws for each specific problem.</p> <p>The reason for taking up U.S. environmental precedents is that the separation of powers has been established in the United States, and the judiciary often determines the constitutionality or lawfulness of legislative or administrative policies. This judicial decision-making role confirms that environmental standards have been established and amended (Setting the Baseline for Environmental Law, Refining the Baseline, &amp; Setting the Limits); consequently, we can evaluate legislation, its operation (enforcement), and related judicial structures in a multifaceted manner.</p>			
達成目標 / Course Goals	<ul style="list-style-type: none"> <li>Understanding the style and composition of scientific papers and becoming accustomed to the typical usage of technical terms in English.</li> <li>Understanding the context of U.S. judicial decisions and learning how to read environmental precedents.</li> <li>Examining the background of the U.S. environmental protection system and operation and obtaining the proper perspective for analyzing actual environmental legislation and practices.</li> <li>Reading and clearly understanding the viewpoints behind the establishment of environmental standards and their amendments (Setting the Baseline for Environmental Law, Refining the Baseline, &amp; Setting the Limits) as expressed in judicial decisions that set environmental precedents.</li> </ul>
